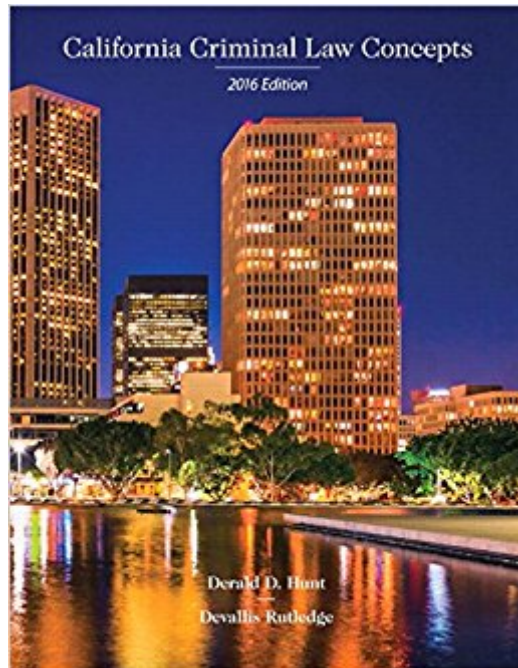

## Customer Reviews

A very poorly written textbook. Definitions and explanations are overly complicated, dense, and convoluted. If this were a cookbook, it would say things like "Bake at 350 degree, but not before stirring. Also, add 1 c. milk before stirring." It's kind of a mess. And if they truly feel it's necessary to publish entire chunks of penal code, they should put it in an appendix while merely putting a condensed explanation of their meanings in the main text. It would also be useful to occasionally explain the examples of cases referenced instead of just stuffing as many People v. Name citations as possible into minimum space. The way this book is written, it might as well be a printout of the penal code. It has almost as little explanatory or educational content. There are practice tests in each chapter, but they are formatted in the most bizarre and confusing manner possible while often asking about things that weren't really covered in that chapter.
