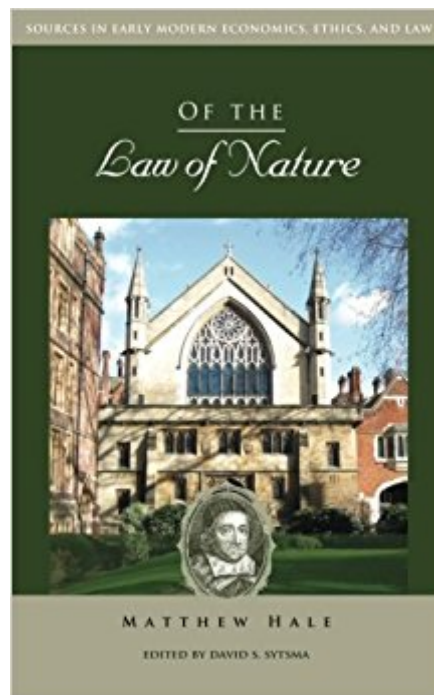

## Synopsis

Hale's treatise, which was likely written as part of his personal meditations and was circulated among English lawyers after his death, reveals not only the close relationship between law and theology in his thought, but also the importance of natural law to early modern legal thought.
